Editorial

Fix the Water!

Why is our section of Rock Creek being left out of the fix for the combined storm sewers?

DC has an antiquated sewer system that often leaks raw sewage into our streams and rivers—ultimately reaching the source of our drinking water. There is a plan to fix the system, but it looks like the Crestwood community is being told to wait until 2015 for Rock Creek to be addressed, while the Anacostia River is going to be fixed sooner. We believe the city needs a comprehensive plan to urgently address water quality in all affected areas.



DC and Rock Creek Park officials recognized long ago that there is a serious threat of pollution in the southern section of Rock Creek Park, near Crestwood. Warning signs were posted near the creek. Studies have counted a larger number of combined sewer overflows near Rock Creek and Piney Branch than elsewhere. Yet our area (adjoining Rock Creek and Piney Branch) is not listed for action until 2015.

As background, one-third of the city is served by a system of combined sanitary and storm sewers. During heavy rains, these sewers frequently overflow and discharge millions of gallons of raw, untreated sewage directly into Piney Branch and Rock Creek, according to documents released at the public meetings about the city's Combined Sewer System Long Term Control Plan. Each year, there are about 30 storm sewer overflows near Rock Creek, which can contribute to high bacteria levels and concentrations of other water contaminants, like lead and zinc. WASA (the Water and Sewer Authority) has said that this is harmful to certain aquatic life and a potential danger to humans. So why aren't we DC residents being protected?

WASA is the organization that receives project grants from the US Environmental Protection Agency to assist public water systems in financing improvements to protect public health. We are federal taxpayers who need just such assistance. Congress is considering the 2007 Water Resources Development Act that would prevent raw sewage from flowing into Rock Creek and the Anacostia and Potomac Rivers.

Meanwhile, the WASA project is being done in conjunction with the DC Department of the Environment and its agent, the US Army Corps of Engineers office at Blue Plains. Why aren't they considering the impact to Ward 4?

The City's Combined Sewer System Long Term Control Plan specifically provided for the separation of the combined sewers and the consolidation and elimination of 13 outfalls. Yet, information provided to the Crestwood Citizens Association concerning the EPA's recent release of funding projects only referenced four outfalls and did not include any that abut the neighborhoods along Rock Creek, where we live. This is a matter of national, regional and community public health. It also is an issue of environmental justice and due process. Who is protecting us?

It's time to fix the water for all of us. Yes, this will be an expensive proposition. But that's all the more reason to invest wisely and spend the money in all the places where it will do the most good.


2007 In Review

From the president:

It's been a memorable year. And as 2007 draws to a close, it is time to take stock of the accomplishments of the Crestwood Citizens Association. Because of our hardworking and dedicated Board and members, we continue to serve Crestwood. I am proud to say that the Crestwood Citizens Association continues to have a growing membership—now totaling 172 families.

Here's a look back at a very good year:

- PEPCO representatives came to our **January 16** Association meeting to highlight efforts to reduce the number of power outages in Crestwood. Our neighborhood is at the end of a very long feeder line (right). For two years the Association held PEPCO's feet to the fire to improve the reliability of our service. The frequency of outages has now been greatly reduced.



- The city's Real Property Tax Assessor joined us at the Association's **March 20** meeting to discuss how our taxes are calculated and the assessment can be appealed.



- The Crestwood Directory (left) was updated and distributed to members (special kudos to Tom Chused, Bill Bentley and our network of block contacts).

- The Association co-sponsored a candidates forum on **April 24th** (along with the North Portal community) before the special Ward Four city council election. We also published a survey of views expressed by the candidates—and posted responses to an Association questionnaire about issues of special interest to Crestwood.

- Mayor Adrian Fenty (right) spoke at the Association's **May 15th** meeting, where we also elected a new slate of officers.



- Association Members participated in the first Rock Creek Park Bioblitz **May 18-19**. Volunteers identified more than 660 unique species of plants



and animals in the park.

- The Kids Team organized the Association's annual Fourth of **July Kids Parade** (left).

- Our new Ward Four Council member, Muriel Bowser (right) spoke with members at the Association's July 17th meeting.



- The grills were smokin' at the annual Sunday after Labor Day picnic on **September 9** (thanks to the Sessions and Sussman/Braden families).

- At the Association's meeting on **September 18th**, the Director of the DC Department of Transportation, Emeka

Moneme, fielded questions on a wide variety of transportation issues—including road projects such as Broad Branch and Klinge Roads, Metro improvements, and the proposed pedestrian pathway down Blagden Avenue (site pictured below),



- CCA members attended an ANC-sponsored meeting **October 4** to support plans to build a path down Blagden into the park—pressing city officials to construct the path along the safest route.

- The Kids Team held a Halloween Party for children **October 28th** at "the point" at 18th & Shepherd (below at right).

- On an **ongoing** basis, the Association keeps a close watch on crime in the neighborhood. We post monthly crime statistics on the web, and representatives from the Metropolitan Police



speak with residents at nearly every Association meeting.

- The Board updated Crestwood's Neighborhood Plan to ensure the preservation of our residential zoning.

- We worked to keep Powell Elementary School from closing. It now looks as if both Powell and West will remain open, and Powell may become a magnet school from pre-K to grade 3.

- After planting 22 trees in November of 2006 as part of our partnership with Rock Creek Park Superintendent Adrienne Coleman, Dan Smith of Casey Trees, and Friends of Rock Creek, we continue to water and maintain the new trees at "the point." We hope to add a demonstration project to highlight native plants as part of our effort to eradicate vines and other invasive plants. We have encouraged members to plant native trees in their yards.

- Our Communications Team maintains the Crestwood website, where this year we posted the Crestwood Handbook and our contractors guide.

- We participated at meetings of the Federation of Citizens Associations.

- We organized the Association's historical archives for our 32-block area—including correspondence, directories and minutes of meetings dating back to 1941.

- We have been communicating with WASA, encouraging them to make water quality issues in our part of Rock Creek a top priority. [See editorial on page one]
